1. Geographical Nature:

- 1.1. Port Condition: International sea port
- 1.2. Position: Latitude: 13°46'33"N Longitude: 109°15'00"E
- 1.3. Tidal regime: Irregular semi-diurnal.
Max tide: 2.2m. Min tide: 0.5m. Average fluctuation: 2.0m.
Max drafts: F/9.00m A/9.50 m (with tide) with 0.50m trim. UKC : 1.0m
- 1.4. Channel: Length: 9km. Depth: -11m. Width: 110m. One-way operation.
Channel is equipped with light-buoys (13 buoys) and leading marks.
- 1.5. Weather: Sunny season: January to late September.
Raining season: October to late December

2. Navigational Regulations:

- 2.1. Pilot Station: Latitude: 13°44'18"N Longitude: 109°15'18"E
- 2.2. Anchorage: Within Rectangular (WGS84); P1(13°44'32"N; 109°15'00"E), P2 (13°44'37.5"N; 109°15'29"E), P3 (13°43'33"N; 109°15'42"E), P4 (13°43'28"N; 109°15'12"E)
- 2.3. Pilotage: Compulsory for GRT ≥ 2,000mt.
- 2.4. Communication: Port Control: VHF CH16 - Pilot: VHF CH12
- 2.5. Tugboat Service: Compulsory for all vessels with LOA ≥ 80m. Exemption for vessels with a bow thruster might be granted by Port Authority on a case-by-case basis.
Total 07 tugboats with power range from 800HP to 4059HP
- 2.6. Restrictions: - Airdraft: Nil - Beam: Nil
- Draft: F/8.7m and A/9.0m (min trim 0.5m)
- LOA: Less than 200m
- DWT: Less than 30,000mt DWT. Vessel of more than 30,000mt must have special permit from Port Authority on a case-by-case basis.

- 3.1. Working Shifts: 04 shifts (0000-0600; 0600-1200; 1200-1800; 1800-2400)

3.3. Storage Facilities: Total port area: 306,568 m2, of which:
Warehouse/shed: 20,960m2. Open storage: 201,000 m2. Tank: 12,000 m3.
Total storage capacity: 200,000mts, including 48,000 m2 for stacking containers.

4.Services:

- 4.1. Garbage Dumping: Compulsory. Every 02 days.
4.2. Fresh Water: Available. Supplied by pipeline or motorboat.
4.3. Bunker: Available. Order must be placed 03 days in advance.
4.4. Workshop: Only minor repair work available.

5.Other information:

- 5.1. Berthing Priority:
1. Container feeders
2. Vessels with Despatch Agreement signed between Shippers/ Cnee and Quinhon Port
3. Each Shippers/ Cnee can have only one vessel at berth at one time.
4. Vessel with earlier Notice of Arrival (at least 7 days in advance).
5.2. Vessel Gears: Shorecrane charge is very high. Vessel derricks/ cranes should be in good conditions.
